C. Respondent must provide medical support as described in paragraph 4 on the previous page.

PLEASE NOTE: DCSE may intercept any federal or state income tax refunds to which Respondent may be entitled. DCSE may apply the intercepted amount to the balances noted above. Failure to make one or more timely payments as stated above will result in other enforcement action to collect the entire amount of the past-due balances. Interest may accrue on past-due payments according to the appropriate state's law. According to Missouri law, simple interest at the rate of 1 percent per month accrues on all past-due child and spousal support payments. (Section 454.520, RSMo)
