### Summary on Nicole Marie Ervin Weber -

Prior to 2000 according to Weber family, Nicole Ervin traveled with her parents, Aunts, Uncles, friends nationally, staying here and there due to her parents divorce. Nicole has one child a son named Todd and his father's first name is Jonathan, last name of Todd's father is unknown. Nicole came to San Angelo, Texas to live with a relative, Shirley Jean Ervin age 67 at the 1737 Knickerbocker Rd apt # 34, San Angelo, Texas address (possible grandmother). Nicole Ervin Weber's possible parents are Thomas W. Erwin age 45-address history New London County Connecticut, Dixie County Florida, White County Indiana and Sullivan County Indiana. Possible step mother or mother to subject is a Delynn Renee Ervin (Fain) age 39. We checked Connecticut Birth records and found no birth for mother Nicole Ervin or a son Todd Ervin. *If Nicole used Todd's father's last name as hers we would need that name to search further.* Criminal, civil, marriage and divorce records are all kept by DATE per City in Connecticut and we would have to know the date and city of any such in order to find a record. In San Angelo, Texas after her marriage and criminal charges filed against her new husband Zack Weber for intentional bodily injury to her son. Nicole Weber was working at Wal-Mart on or about January / February 2003 time period but quit two days after she filed the charges against Dr. Tim Emerson on 2/12/2003.
