## RE: Errors and inadequacies in the SCORE voter registration system

We have completed a very preliminary analysis of Boulder County's SCORE voter files dated June 23<sup>rd</sup>. We have identified significant problems that suggest that the SCORE application is not robust, and that the data are not correct.

We are deeply concerned that the SCORE application has not met expectations, and is being put into production before it is production ready. Mail-in ballots are being shipped on July 11<sup>th</sup>. These ballots have been prepared using this faulty data.

Coupled with the Clerk's high pressure push for mail-in voting, which has increased the reliance on an accurate voter database, the inadequacies outlined below raise an important question. How will the public verify that voters have not been disenfranchised because of SCORE problems?

## 1. Voter Registration file

In addition to the specific errors and incomplete data identified below, it is of major concern that the SCORE application appears to lack the edits and consistency checks that are required to protect voter data from contamination now and in the future. One of the principal benefits of a database is to ensure data accuracy and consistency. It looks like Colorado may be paying for a system that does not follow common data quality and integrity practices.

It is also a concern that the application has not addressed the requirements of the political party and those who work with voter data including political campaigns, canvass boards, and poll watchers.

The following are illustration of specific errors and inadequacies:

- A. Non-citizens 35 people are recorded as "US CITIZEN = NO". If these people are not citizens, why are they included in the voter file? If they are citizens, why are they incorrectly marked as non-citizens? (See TABLE R1 Citizenship.)
- B. No-precinct 33 people are recorded with no precinct number, and 1 person is assigned to an invalid precinct, number 9999. This suggests that the SCORE system lacks the required data consistency checks. It also suggests that the precinct number is entered by hand, rather than by calculation based on residence address. (See TABLE R2 Precinct Errors.)
- C. **Absentee voters** Only 11 people are recorded as absentee voters for the 2008 election. (See TABLE R4 -- Absentee Voters.)

This is suspicious. We know of at least one person who submitted an application to vote absentee for the 2008 Primary Election who is not included in these 11. This person should be included on this list. (See TABLE R3 – Absentee Problem.)

This subject is of particular concern because the Boulder County Clerk conducted a possibly illegal "Permanent Mail-in" marketing campaign, and intimidated voters who wanted to vote by mail-in ballot for the 2008 election only. Possibly, many absentee voters are incorrectly recorded as permanent mail-in voters.

- D. **Missing addresses** 12 people are registered to an address that is not known to the system (address not in ADDRESS\_LIBRARY\_ID TABLE). (See TABLE R5 Residence not in library.)
- E. **Unedited addresses** The SCORE application does not edit address information (and possibly other information). This means that people can accidentally or intentionally claim a non-existent residence address.

Also, the address information does not appear to comply with USPS address quality recommendations. One example of this is the unit number for BEACHLER, BUHL, and LARSON, DAVID BRIAN. (See TABLE R6 – Unverified residence.)

- F. **Missing data** Key information is not included in the file. For example, there is no indicator for "1<sup>st</sup> time voter who registered by mail".
- G. **Missing electors** There are no registration records for confidential voters. This means that there can be more ballots cast than registered voters in a precinct. (It is not necessary to remove the entire voter record in order to protect the privacy of the voter.)

## 2. Voter History files.

We were also provided a set of Voter History files. We have nothing good to say about these files. There is so much wrong that we will not confuse the Voter File problems described above by discussing these Voter History file problems. Be forewarned; the Voter History files are terrible and reflect an amateurish implementation.

Obviously, this brief review of the files is incomplete. The fact that there are so many issues at this late date is very disturbing.

We are also very concerned that the public has been cut off from seeing the SCORE status reports. The last published report is dated May 10<sup>th</sup>. (See <u>http://www.elections.colorado.gov/DDefault.aspx?tid=1025</u>)

Thank you for anything that you can do to expose these issues and get answers to our concerns. Also, thank you for all that you have done to protect the integrity of the Colorado Election System.
